Mayor Feldman asked City Clerk Wida if they had anyone wanting to speak. She said they did not.

City Planner Richmond reviewed the Staff report concerning rezoning requests for the Serenity at Seelye Brook project. She shared the Planning Commission's recommendation to approve the Comprehensive Plan Amendment and the rezoning.

Mayor Feldman shared that the packet states that Anoka County has reviewed the request and did not have significant concerns with the potential future development of the site. He stated that it seems like the curve is not an issue with Anoka County. Richmond said that was correct and their comment was that they would suggest clustering the driveways as much as possible to keep the access points closer together.

Mayor Feldman asked if the lots will be five acres. Richmond stated that they are not to the subdivision process yet. She added that the density is one lot per five acres, but in the rural residential district lots can be two and a half acres. Mayor Feldman asked the intent of the developer. The developer, Eric Vickaryous, C&E Ventures LLC, came forward and stated that he would like to do three or four lots in this area. He discussed the restrictions based on the wetlands. He stated that the smallest lot would be a little over four acres.

Robinson stated that the County will be assisting the developer with safe access points.

Bauer stated that his biggest concern is that one of the lots will be smaller than the other. He stated that he would like to see all of the lots be five acres. He added that he is otherwise for this.

Richmond reviewed the Staff report concerning code revisions. She shared the origins of these revisions are from the audit from the Minnesota Pollution Control Agency and updated Private Development Standards. She reviewed the changes. She shared the Planning Commission's recommendation of approval for the zoning code amendments.

Mayor Feldman stated that taking out gray areas and making clarifications are always good thing. He noted that this will have a good end result.

Muehlbauer agreed and stated that this seems to be mainly housekeeping updates that will help with future growth of the City.

Robinson agreed and appreciated Staff's work on keeping this up to date.

Bauer asked for clarification on the cul-de-sacs. Richmond explained that currently there can be 16 units, not just in the cul-de-sac itself, but also the road.

11. REPORTS

A. Fire Department Monthly Report - March 2023

Fire Chief Schmidt reviewed the Fire Department March report. He highlighted the response time with over a minute decrease from last year, a small decrease in run volumes from last year, and the slight increase in average numbers of firefighters per call at 5.3. He stated there was a standard delineation of fire versus EMS runs in March. He noted that variance usage was low for the month. He added that there were two ambulance response times over 20 minutes. He noted that the numbers are increasing in April. He stated that there were eight initial fire inspections and six reinspections.

Mayor Feldman noted that glucometer use is up. Schmidt stated that this is commonly used. Mayor Feldman mentioned that the EMS calls were greater than fire again, which is no longer a trend and seems to be how things will go for the future.

Muehlbauer stated that it was a good report and asked Schmidt to send the Council's appreciation to his firefighters.

Robinson asked if any of the calls for the glucometer were repeat patients. Schmidt stated that he is not sure if any of them were repeat calls, but noted that it is not uncommon to have repeat calls. He stated that this has been increasing year over year for the last five years. Robinson asked if there are any additional services that can be offered, such as a follow-up, with these patients. Schmidt shared that there are a number of challenges surrounding this, including a lack of continuity of care between emergency response, emergency room visits, and primary care visits. He stated the other challenge is that these things would typically be escalated to the County and a lot of things need to be triaged by the County. He stated that there are other resources and noted that community health is a growing field. He stated

that there has been a decline in primary care doctor appointments, which makes primary care more difficult to access. Robinson asked for the definition of community health. Schmidt explained that a lot of departments in surrounding areas have created a community paramedic program as well as community EMTs that can perform site visits and help people navigate their medical conditions to reduce 911 calls. He stated that this would be a staffing challenge for the City right now but would like to see it in the future.

Bauer stated that it was a great report. He asked about variance usage and noted that the glucometer uses were not necessarily just for blood sugar tests and could have also been to help determine what was wrong with a patient. He stated that the glucometer is just one of the tools used on a call. He asked Schmidt to tell his Staff they are doing a great job.

Udvig said it was a great report and stated that she liked seeing the number of fire inspections done. She shared her appreciation for Schmidt and his Staff.

Mayor Feldman stated that the fire engine was on the consent agenda this evening. He asked what the original price of the unit was. Schmidt stated that he did not have the number off the top of his head.

Mayor Feldman asked if the change with the new lieutenants has been beneficial. Schmidt stated that it has certainly helped, especially with dividing out the duty officer rotation more significantly.

12. COUNCIL MEMBER REPORTS

Udvig stated that she attended the work session last week and reminded residents to watch for children and pedestrians who are out walking or biking.

Bauer mentioned that he also attended the work session and there was a lot that was discussed. He apologized for being absent at the last few meetings due to medical needs.

Robinson stated that he attended the Planning and Zoning meeting as well as the work session meeting. He added that he attended the Recycling Day last Saturday.

Muehlbauer stated that he attended the Citizens Academy at the police station and the work session meeting. He noted the upcoming EDA meeting on May 3.

Mayor Feldman noted that he also attended the work session. He stated that he will be attending the EDA meeting. He thanked all of the Staff and Council for all of the work that they do and the time they put in. He added that there is a lot of work that is done behind the scenes that the residents do not see. He shared that he is proud to be the mayor of a City and Staff like St. Francis. He reiterated Udvig's comment about being safe and cautious of pedestrians.


